Additional Information

- Prices do not include 7% sales tax.
- All Family Memberships include spouse and up to two children under 23 who live in the same household. Each additional child is \$300.00
- Primary residence for Non-Resident Membership must be more than 100 miles from Fox Hollow Golf Club. Membership is valid up to six months per fiscal year.
- Play for Junior Members must be approved by professional staff and may not be at peak times.
- Member cart fees are \$20.10 per person + tax for eighteen holes and \$12.15 + tax for nine holes.
- Members are permitted to walk at the fee of \$20.10 + tax for eighteen holes and \$12.15 + tax for nine holes or an annual walking trail fee of \$500 + tax. Seasonal walking restrictions run October 1 through April 30th. For family memberships with a child under the age of 16 there will be no walking fees.

Privileges

- Tee time reservations fourteen days in advance.
- Participation in Member Only events.

Billing

- Billing for year round members will be done bi-annual (October 1st and April 1st).
- Billing for Non-Resident Members will be done bi-annually (October 1st and January 1st).
- Memberships unpaid past thirty days of invoice date will be considered delinquent and could be subject to a service fee or a reinstatement fee.

CLUB RULES

Membership at Fox Hollow Golf Club is a privilege and all members are expected to comply with reasonable rules. Initial and continuing membership is contingent on compliance with the following rules. Violation of any of these rules or other misconduct may result in disciplinary action by Club management at its sole discretion. This list is not all-inclusive and conduct not specified below may subject a member to discipline, including suspension or revocation of membership. Members are expected to interact with other members and Club employees in a respectful and courteous manner at all times.

1. The Course and Club facilities will be open on the days and during the hours established by Club Management. Days and hours of operation are subject to change with or without notice.
2. All food and beverages consumed on Club property, including special events, must be furnished by, and purchased from the Club. Unless prior written approval from Club management.
3. With the exception of service animals, pets are not permitted in the Club House.
4. All Club employees are under the supervision of Club management and no member or guest has the right to reprimand or otherwise discipline any employee for any reason. In the event a member has a concern about an employee, he or she should report those concerns to Club management.
5. Smoking is not permitted inside the Club House.
6. The Club will not be responsible for loss of, or damage to, personal property left on Club premises. Members who do not secure their vehicles do so at their own risk.
7. Club property shall not be removed from the premises.
8. The use of profanity in the Club House, including but not limited to, its restaurant, banquet facility and patio, is prohibited.
9. Club Members are not permitted in the Club House kitchen or service areas at any time.
10. In compliance with State Law, no one under 21 years of age will be served or supplied any alcoholic beverage(s). Service of alcoholic beverages may be refused to any person if in the opinion of the server a violation of the laws of the State of Florida would occur, or the person requesting service should not be further served (either because of an apparent or probable intoxication). Any person who is refused service shall abide by the server's decision and not conduct himself or herself in an unruly or otherwise discourteous manner.

MEMBERSHIP GUIDELINES

- Club Members are permitted to use the facilities under the guidelines and rules set forth by the Club Management.
- Memberships are not transferable. Members will not be entitled to a refund of any purchase price, Membership Dues or other fee.
- Members who encounter unexpected circumstances and are unable to utilize Club privileges may be eligible for a leave of absence. Contact Club management as soon as possible to discuss available options.
- Members who are suspended are prohibited from all areas of Club property and cannot take advantage of any of the benefits or privileges of club membership.
- Children who are included in a family membership must have staff approval for playing times. Play is at non-peak times. Primary member(s) are responsible for ensuring minors comply with these guidelines
- Members and their guests are expected to adhere to the Club's posted dress code.

Club management reserves the right to amend or modify these rules when necessary and will notify the membership of any change in writing.
